OFFICER PRESLEY of Narcotics had advised SGT. BAIER and MYSELF that he and LT. RIGNEY had been called to the Waco High School where a w/m SUBJECT described as TERRY LEHRMAN of Rt. 3, Box 515, Waco, had been to the school either 11/2 or 11/3/82 and a SUBJECT had asked for a JILL MONTGOMERY.

SGT. BAIER and MYSELF did go to Waco High School where we made contact with MS. TALLEY where she told us that the officer secretary had called her after she had heard the SUBJECT ask for JILL MONTGOMERY and then she had gone back to the office herself and had asked the SUBJECT who he wanted to see. When he had mentioned again, JILL MONTGOMERY, she told him that the girl no longer was in school, that she had been murdered. The SUBJECT was then asked to leave the grounds. However, before that he had told her that he was not looking for JILL but for JOE MONTGOMERY, who they did have enrolled.

OFFICERS talked to JOE MONTGOMERY, JR. of 615 Garland, B/M, 2/15/65, who is a Jr. at Waco High, 754-5224. In talking to him he did tell us that he did know TERRY LEHRMAN since he was going to school in China Springs last year. He told us that the involvement with TERRY LEHRMAN was that TERRY was wanting to sell him a motorcycle which he, MONTGOMERY, had later learned that the motorcycle was stolen, that he had reported this incident to Det. HAWTHORNE of the Waco Police Dept. We were able to ascertain that JOE MONTGOMERY, JR and LEHRMAN's younger brother had gone to school together. MONTGOMERY, knowing that, was involved in burglaries on Lake Shore and also involved in some dope.

After the discussion with JOE MONTGOMERY, JR. and his knowledge and relationship with TERRY LEHRMAN, we feel that the name of JILL MONTGOMERY may have been a mistake or a misinterpretation by the school personnel. However, we will talk to LEHRMAN as soon as Det. HAWTHORNE does have something on this SUBJECT on the burglaries or the motorcycle theft.

Also will wait until Crimestoppers does have something on this SUBJECT as to whether we will interfere with any investigation that is being run at this time on TERRY LEHRMAN.

On this date, 11/10/82, we did go to West Texas where we made contact with JIMMY DON LEWIS of Rte. 1, Box 50 P, Tokyo, Texas. This SUBJECT is a W/M, 2/11/63, 6'3, 195, Waco PD#27601.

CONTINUED:

Det. HOLSTEIN and Sheriff's Officer LARRY ABNER had been looking for this SUBJECT back in the July of '82 as a Possible SUSPECT on this triple murder. After obtaining this address Det. BAIER and MYSELF did go to this address where we made personal contact with JIMMY DON LEWIS, being that his name had come up in reference to a Suspicious SUBJECT that had come to 7-11 Store at Cobbs and Valley Mills carrying a brass knife on a chain on his belt and also making inquiries about the triple murder. In talking to JIMMY DON LEWIS, he did show us the knife which had been described by the witness which he had on top of his tv in a bowl. This knife is described as approximately three to three and a half inch blade with the name ISTANB inscribed on the handle. This knife is not a usable knife, but possibly a letter opener. The blade on this knife was very dull, made out of brass. After talking to JIMMY DON LEWIS, felt like he would not be a SUSPECT in this case. This contact with JIMMY DON LEWIS was made at his residence at 11:45A; 11/10/82 in the presence of his grandfather, BARNES LEWIS.
