Upon 10-27-82, at midnight, LT HORTON of CIS, SGT. DENNIS BAIER, and myself, did make a trip to Kerrville Texas, after LT HORTON had received a phone call of a suspect they had in the jail who had admitted to killing the three people at the Waco Lake, which involved this victim JILL MONTGOMERY and RAYLENE RICE.

The suspect was found to be JIMMY DEAN ROE, white male, 9-4-59, 5'9", 160, brown/brown. The subject had an address of 2109 Live Oak.

Officers arrived at Kerrville at approximately 5A, on 10-28-82, where we made contact with LT. DANNY CORTEZ, of the Kerrville PD, 600 Main Street, bus. ph/257-8181.

In conversing with LT CORTEZ he stated that the subject, ROE, had stated that he had killed approximately 6-7 people in the last year or so, and that he had come to Kerrville from San Antonio Texas, and that he had stopped at a church and had been told by the Lord to get his business straight and get it off his chest. Therefore, he had come to the Police Department and wanted to turn himself in for the murders.

LT HORTON did talk to the subject in privacy, where after the discussion/interview with LT. HORTON, LT HORTON advised that the subject possibly did not have anything to do with our murders, being that he was accounting the chain of events different from what they appeared to be when the bodies were found. However, he said that the subject seemed to be talking pretty straight into the BETH BRAMLETT, who had been shot in Axtell Texas approximately 2-3- weeks later.

Subject was transported back to Waco on voluntary basis, after contact had been made with DAN WYENBERG of the S.O., McLennan County.

LT HORTON and myself did interview JIMMY DEAN ROE on 10-29-82, at approximately 12:30P. The subject still contends that he had killed these people in Koehne Park and not Speegleville and the manner in which he stated he had killed the people was by slashing, and not by stabbing and that he had let them lay where they fell, where they had been completely clothed. After interviewing this subject, it was found that he was probably hallucinating or making the story up. We did take him to the scene of where the car was found at Koehne Park, where he stated

the scene where he had killed the people and after arriving at this location of Koehne Park he was unable to tell us exactly where it was that he had done the killings.

Earlier in the interview session, he had mentioned that he had ESP, and that he sometimes dreamed of the people being killed, and that the person doing the killing was him. Therefore after this information was received from him it was felt by LT HORTON and myself that the subject was just making up a story, for some type of recognition on his part, or trying to get famous on somebody else's doings. As of this time, the Sheriff's Office does not have anything different on their murder either, where this subject was admitting to that murder
