At approximately 7:45P, 7-14-82 I was notified that a body of a WM was found bound, gagged, and stabbed to death in Speegleville Park, #3. I went to the scene and found that Det. MINAS, Sgt. SIMONS, Officers WILCOX & REYNOLDS were there and had found two WFs dead. Sgt. KIDWELL was called to the scene and officers and I conducted a limited crime scene search and the bodies were removed by Connally Compton Funeral Home.

On 7-15-82 in the a.m., a RICK GUTHRIE of 2630 Glendale, 753-1084 came to my office and said that he and a PHIL SCHULZE drove out to Koehne Park at about 9:15P, 7-13-82 to drink some beer. He said that they had driven in the circle area of Koehne Park and saw the orange Pinto parked and no one was around the car. He said that he also remembers a group of blacks dancing on one of the picnic tables. Parked next to the Pinto was a white truck possibly a pickup or a larger type truck with toolboxes down both sides and something written on the door of the truck. The white truck was not in good shape, beaten up, and he does not remember seeing the license number on the truck. He also said that he thinks that a new small black or dark colored car was parked to the right of the Pinto. At about 10:00P the blacks left the area and they drove up and parked next to the Pinto. He noticed that the Pinto appeared to have been locked up and the front seats were pushed up as if two people had gotten out of the back seat. GUTHRIE said that they left the circle about 10:15P.

At 3:00P, 7-15-82 Officer LYON came into my office and said that an informant of his had told him that at approximately 3:00A Wednesday morning, 7-14-82 he was in the Rally Car Wash at N. 19th and Vivian and saw a yellow Cadillac come into the car wash with blood on the right front fender and door. The car is thought to be about a 77 or 78 model Coupe De Ville Cadillac. The driver was described as a WM, 30 to 35yoa, tall and slender, with short hair - color unknown. He told the informant that he had run over a dog and that was how the blood got on his car. The informant had seen the man around, but does not know his name, but he runs with DAVID WILKINS. There was no damage to the car that informant could see.

On 7-15-82 MIKE ROYALS, home phone number is 754-6661 and business phone 772-4488 called and said that he had remembered an incident in the Mexia area he thinks about 15 years ago

that was similar to this case. The person involved was a ROY DALE GREENE of 1819 Herring. He is a WM, 35yoa. GREENE was sent to the pen, however, he got out and MIKE ROYALS thinks this person is very weird and that he is capable of committing such an offense as this.

On 7-15-82 a CARLOS CORDOVA of the Cora Lee Home Unit #437 of the Methodist Home called and said that JILL had been dating a boy and had broken up with him. He did not know the boy's name, but he drives an orange 63 Ford pickup. The boy is about 17yoa, 5-8, 130 lbs. He said that the boy was upset because JILL broke up with him and started dating KENNETH FRANKS again. CORDOVA said that he would try to get the name of the boy, but he isn't sure if he could or not.

On 7-16-82 at 8:02A, I received a call from the Belton PD and the Detective said that he wanted us to know about three boys from the Methodist Home who had run away. He reported that they had stolen a car in Waco and had driven the car to Rosebud, left the car there, stole a car in Rosebud and drove it to Belton, left that car there and stole a car in Belton and drove it to Giddings, Texas where they were arrested in Giddings. The boys from the Home were BRIAN KITZMILLER, WM; a MARK ROTH, WM; and GLEN SINGLETOWN, WM.

On 7-16-82 a Mrs. OLIVER, manager of the Ivy Square Apts., her apartment number is Apt. #212, home phone 752-0340 called and said that between 2:00P and 3:00P on 7-13-82 the two girls came to her office and wanted to rent an apartment. JILL MONTGOMERY told her that she had a check and would have enough money to pay rent for one month and hoped to get a job in time to pay the next month's rent. The two girls were alone, however, Mrs. OLIVER said that she saw them talking to WMs that she thought were runaways from the Methodist Home. LINDA FUQUA of Apt. #225 at Ivy Square works at the Methodist Home and had told Mrs. OLIVER about the runaway boys from the Methodist Home.

7-16-82 received information that a JOHN EVANS who lives on Old Steinbeck Bend Road, home phone 756-2616 had told some friends that he was out at Speegleville Park camping out with some people from Baylor Camp and that between 10:30P and 11:00P, he had heard a terrifying scream, and he felt that it might have been one of the girls screaming. He had reported this

to his counselor a KRISTA BROWN who is staying in Martin Hall at Baylor. The phone number of Martin Hall is 755-1665 and the person who is the overall person in charge of the Baylor Camp is DANNY BOUSKA whose phone number at Baylor is 755-2930. JOHN EVANS is supposed to in the first chance he gets and give us further information, however, JOHN has not come in at this time.

On 7-16-82, a psychologist had come down from Euless, Texas and has given us a profile of the person that he thinks could have been involved in this incident. He said that this person is possibly in his late teens or early twenties and at the best as a high school education and does minimal labor such as an assistant carpenter, or works in a fast food restaurant, or plumbers assistant. He feels that the person has a history sex offenses, that he will take things from the victim, not necessarily knowing the victim, but he patrols around looking for victims, and is likely to return to the scene. He is possibly a psychopath. He is a loner, probably is not married, reads pornography books on bondages and this type of literature; that due to the overkill that was committed in this offense he feels that it was probably someone who was taking out the feelings that he has against possibly his mother, his aunt, or a girlfriend who has jilted him in the past and so forth. He stated that the person may be a casual acquaintance to one of the victims. He is not neat in his dress and if he has a car, it would be a car that it is not kept clean.

On 7-16-82 a DAVID PEARCY of 524 Mountainlake, 772-1524 and a CANDYCE SATTERWHITE of 1800 Laurel Lake, 772-1300 came into the office and stated that they were out at Koehne Park on 7-13-82 and that they arrived at the circle area at approximately 10:15P where they drove a 1978 Malibu silver and gray in color and had parked their car close to the orange into belonging to one of the victims. They stated that at the park was a truck that appeared to be bigger than a pickup, possibly a one ton type truck, white in color and they were not able to remember the license number or anything. However, Ms. SATTERWHITE stated that she remembers the letters on a magnetic sign were white letters on a red ground with the letters "CHAZ" and some other writing but she does not remember this. These two individuals have agreed to be placed under hypnosis if it is necessary. They
