At 11:07 AM, 7-28-82, I did have a Arthur Rusty Escott come to the office for an interview in reference to this offense.

The information that had been passed on to the detective office on 7-15-82 and 7-16-82 was that the subject named Rusty was passing information that a Becky Desmarias had talked to a Tab Harper on Wednesday morning before noon and before the bodies had been found and that this Rusty had talked to Becky and this was what Becky had said making officers believe that Becky Desmarias knew about the murders before the bodies had been found. Therefore, after receiving information from several people that the information had come from Rusty, we did pick up Becky Desmarias for an interview twice in reference to this. After getting more information that a subject Rusty was giving out information of a Becky and that he, himself, had seen the girls and Kenneth Franks get into a van at Koehne Park belonged to Harper we then picked him up and brought him in.

During the interview I asked Rusty to give me the whole details of the first meeting with Becky at Airport Park when he had overheard the conversation about her talking to Harper before noon Wednesday, 7-14-82. He at this time took his time to think the situation over and he then told me that he had been swimming with some friends at Airport Park and that he had met with Becky and another tall girl about the size of Becky which had dark skin however he does not remember if she was a mexican or had a suntan. Then he told me that this meeting had been on Thursday morning, 7-15-82, then with the day change would mean that everybody would have heard of the bodies being found at Speegleville Park at that time. Rusty then told me that he was positive that he had talked to Becky on Thursday, 7-15-82, instead of 7-14-82.

Rusty does also not remember if Becky told him that she had been contacted on Wednesday or Thursday morning either but now being that it was on Thursday that she talked with him he feels that this is when she had talked to Harper being that she does know him.

Rusty apologized for making the mistake on the day and also that the information that he had heard from Becky.

I then did ask him directly what he had seen or saw at Koehne Park or if he had been at Koehne

Brickwell Unit. A meeting has been set to talk to Richard Lopez at 9:30 AM on 7-30-82. An interview to see what he knows about Jill Montgomery and the murders.

t. Holstien and myself then went to 1515 College Drive, Apt #218, where we talked to Gayle Kelley and showed her the picture of the subject with Jill Montgomery and she identified him as Richard Lopez also. She stated that she did not know very much about Richard. I did ask Gayle Kelley if she knew a guy by the name of Robert that Jill might have been dating and she stated that she thought that a Robert would be Robert DeLaRosa and she was dating on the sly. She stated that she was not allowed to date being that he was over the age that they were allowed for the home. She stated that mentioned something about the dates with Robert that she had a great time and had lots of dope to deal with. She has never met him or knows anything about what he drives.

I did also find at the home that the only other Roberts that they have at the home was a Robert J. Brown, DOB: 1-10-63, who had been the son of a stabbing victim on N. 25th Bob Brown and subject had been released to his mother on April 27, 1978. Another subject at the home that they had trouble with was a Robert Menchaca who lives at 2120 Proctor. However they had not seen this subject or heard anything about him or if he is still harbouring runaways or not.

At 4:50 PM, 7-28-82, I talked to a Ken Adkinsson who stated that he had heard information at Koehne Park that Ken Franks had had a fight with a guy by the name of Torres who was husky but about 5'10" or 5'11" with long hair and they were suppose to be arguing about some beer or gas that they were wanting to take out. This was suppose to have happened around 7:30 PM, July 1 Tuesday night of their disappearance. However subject Adkinsson did not have anything else to add to this information. He will get back to me later if he finds out anymore.

9:00 AM this date I did go to a phone list that I had received from Detective Lewis from Mahachie that belonged to Ms. Nancy Shaw where it showed all the long distance calls that were made from her phone or to her phone. I did find two numbers here in Waco and checked them out one being 756-4497 which was made on 6-29-82 at 7:35 AM to Waco. Also the same number 756-4497 was made at 11:39 AM at 7-8-82. I found that that number to belong to the Waco Girl Scouts at 201 West

to Drive. In checking this number I found that the call had been made to a Ginger Yoby of White Home who is employed at the Girls Scouts. In talking to Ginger at 9:05 AM she stated that she had been called by Jill from Waxahachie to let her know that she was coming to Waco to get her clothes and things on Saturday, July 10, 1982. Also said that she was coming back the next week to sign some papers and transfers the same to Waxahachie and that other than that they had a normal conversation as to friends and stuff.

On July 10th at 10:30 AM she had seen Jill and she had picked up most of her stuff from the home and at this time she had told Ginger that she would be back next week with Raylene to take care of her check and other things. Ginger stated that she had heard a lot of Raylene but had never met her and was to meet her whenever they came down that time. Ginger also stated that she did not see Jill on that Tuesday when she was suppose to be there and had not heard that she had been in town until after she had been notified that she had been reported missing. Also Ginger mentioned that Jill had stated to her that she would be back with Raylene on that Saturday and in talking with Nancy Shaw when she was interviewed in Waxahachie they did not make plans for Raylene to bring her to Waco until Sunday, July 11th or either July 12th on a Monday after she had come to Waco to pick up her clothes and found out that she could not get her check during the weekend.

Ginger also stated that Jill had dropped Ken as a boyfriend back in the middle of school near February or March and that they had gone back together for approximately a week and had fought and fought a lot and they had broken up again. She also stated that Jill had run away from home sometime in January and had stayed at a house with Bobby Brem and that they were good friends however she knew that Bobby Brem liked Jill a lot and wanted to go with her and that Jill had mentioned the same to her that Bobby was very interested in her.

had asked her if she had heard or seen a Robert that Jill might have dated. She stated that the only Bobby she knew or Robert was a Bobby Brem that she had gone out with before. Ginger also stated that she had been friends with Jill for a short time when she joined the home in January, 1982 and that she knew that Jill was wrapped up in drugs a whole lot and made a lot

I also checked on a phone number that was listed in the phone list of 755-6179 which the call was made on June 28th at 9:28 PM to Waco. I had checked with the phone company and found that that number is listed to a Mark Ervi of 3704 Sleeper. I have been unable to make contact with the subject at his home. I did leave a card at his door at approximately 11:00 AM this date.

At 12:35 PM this date I received a call from a Bonnie Wood of 708 Penton Lane, phone 799-8520, who is employed at the Waco VA Hospital. She stated that she had heard the news that they were looking for some black people who had been in Koehne Park on Tuesday the 13th and she was wanting to report in that she and a group of her friends and her brother had been in Koehne Park between 7:00 PM and 9:00 PM. She does not remember seeing a orange Pinto at the park other than a white pickup with a subject that had been in there watching people in boats with his binoculars. I made arrangements with Bonnie Wood to come to the Police Station at 5:00 PM this date, 7-29-82 to look at some photos of the Pinto to see if she might remember and then remember what she might have seen that day.
