On 8-26-82 at 10:05A I went to County Jail in an attempt to contact CHARLES SEDIGAS, however, I learned that the subject had been transferred back to Bellmead Jail. I the drove straight to the Bellmead Jail where I did contact this subject whose address is 2013 1/2 Montrose. He is a WM, DOB/2-11-64. He related to me the following information.

He stated that approximately two or three weeks ago, he and a friend of his were on Valley Mills Dr. He did not give me the names of his friends that he was talking to, however, he did state that they were by Jack's Stereo on Valley Mills Dr. He stated that while they were there, that a subject came up in a black Chevrolet van, just plain colored, no picture windows or any thing of this nature in the black van; and this subject got out along with a "Mexican dude" that was with him.

The subject that got out of the van he felt name was TABOR. He does not know the Mexican fellow's name. The fellow TABOR was attempting to pick fights with everyone and stated that he was going to kill someone and that he had already killed someone before and he was attempting to pick fights with all of the kids at Jack's Stereo. The Mexican fellow stated that he knew that TABOR had killed someone and that TABOR was involved with killing the kids at the lake. He does not know TABOR's first or last name, or the Mexican fellow's name. He described TABOR as a WM, 5-9 to 5-10 with short brown hair, 170 to 180 lbs., possibly 25 to maybe 30yoa with a short small mustache.

He stated that one of the two friends that was with him is a DAVID BEATTY who works for Lipsitz and drives a blue Chevelle, but he does not know his address or phone number, and only knows where he works.

Mr. SEDIGAS is being charged with Assault on Police Officer and some other violations that occurred in Bellmead Jail. He stated that he does not know the Mexican fellow and that he does not know TABOR, but he believed that TABOR lived somewhere in the Bellmead area.

The Mexican dude supposedly stated that TABOR had a gun in the van and that TABOR had killed the kids. When the Mexican dude asked TABOR about it, TABOR simply said, "what do you think", laughed, turned around and walked off. This was in response to the question,

"did you kill the kids".

I have since learned that CHARLES SEDIGAS knew the girl found on the railroad tracks in well. He stated that he had known and dated her, but that he had seen her probably two or three days before her death. I am speaking of BETH BRAMLET. SEDIGAS stated that he and BETH had dated for approximately two to three months prior to her disappearing at the party the night that she was killed. He states that he felt like she had been looking for him on the night that she was killed because some of his friends had told him that she had been asking if they had seen him. It is not known if CHARLES SEDIGAS is being truthful in all of this information or not, as subject appeared to be attempting to assist police in an attempt to maybe getting his charges dismissed or reduced.

On 8-27-82 at 9:40A, I received a phone call from an informant who stated to me that a subject JERRY CULVERHOUSE who lives at 2712 Park Avenue had recieved a ticket for being in the Speegleville III area on July 14th at 2:50A. Upon checking further on this I found this to be true, that he had received a ticket, however, the ticket was issued on the 14th, but the violation had occurred on July 5th 1982 and they had only caught up to Mr. CULVERHOUSE on the 14th to issue him the violation of the ticket. Mr. CULVERHOUSE works for Omega Coatings at 801 E. Loop 340, phone 799-5505. I did talk to this subject. Also M. SIMS and myself arrested him for the Capias of not paying the fine for being in violation of curfew in Speegleville III. He was transferred to the County for that warrant. It appears that he was not in the park on the date that the kid were reported as disappearing. Mr. CULVERHOUSE drives a 1971 Pontiac Grand Prix, 82TX DST567. His Texas drivers license number is 11434487.

On 8-27-82 at 10:30A I met with the owner of Pinnocchio's Pool Hall a JIM MORRISON. JIM did not really want to get involved. He simply wanted to relay a information story to me. He advised me that approximately two weeks prior to the death of the kids in Koehne Park that he had a subject JAMES & TERRY GUITERRES supposedly twins 17yoc come into Pinnocchio's and they were practicing for a fool's ball tournament. The fool's ball tournament was scheduled to be played on July 14th, Wednesday, the day after the kids disappeared. He stated that neither JAMES or TERRY had shown up for the fool's ball

tournament, but that they had practiced and this was all that they had talked about prior to the fool's ball tournament, was entering and playing in the tournament. Mr. MORRISON stated me that a subject who works for him by the name of BRAD CLAY had relayed to him some information that the two boys JAMES & TERRY GUITERRES were scheduled to sell KEN FRANKS old green vehicle which they had, but for some reason the deal fell through and KEN FRANKS did not purchase the car from them and supposedly they were very upset and mad because he did not buy the car. The vehicle was wrecked approximately the middle of August, somewhere around the 15th. Mr. MORRISON was not sure, but they did have a wreck in the car in the City of Waco and we could find out the type of vehicle through the accident report. I have checked our records and could find no wreck report made on either JAMES or TERRY GUITERRES with our Records Section. Mr. MORRISON stated that on the day of the tournament, that JAMES & TERRY GUITERRES' mother had called the pool hall looking for the two boys, but no one seemed to know where they were. Mr. MORRISON stated that JAMES GUITERRES was on probation for burglary of a house and he did not know if TERRY was in any trouble or not. He did relate to me that TERRY and a fellow by the name of CLIFF OLIVER had left for California and that CLIFF OLIVER was involved in some hot check deals and he was getting out of town and TERRY had gone with him. Mr. MORRISON has not seen JAMES or TERRY GUITERRES since the day before the fool's ball tournament.

He stated that she had related to him that DANNY's parents di know where DANNY SIZEMORE was, and he stated that it is his opinion that probably JOY knew where DANNY was, also, and that she had probably talked to him sometime in the last two we He stated that he felt that she was indicating that DANNY may know something concerning th triple murders in Koehne Park, but that he had no basis to base this on, other than the fa of the way she was very evasive about the questions which he was asking her. He advised th he wished that his name not be mentioned unless it is absolutely necessary in questioning JOY THRASHER in reference to this.
