On 7-30-82 at 11:00A, one of the BF's in the yellow Ford Torino that had been parked in Koehne Park came to Waco PD and I interviewed her; this subject being MARTHA DENISE TURNER, BF, 20yo who lives at 1111 Clover in Bellmead, residence phone of 799-3033. She works for the Dairy Queen in Bellmead at 799-5051. She related to me the following information.

On Tuesday the 13th of July they arrived in Koehne Park somewhere around 8:00 to 8:15P. She stated that there were four other subjects in the car with them, a subject PINKIE, a subject BONNIE, BYRON, and HAYWARD. She stated that they were dancing, were drinking beer, and enjoying themselves at one of the picnic tables at the Circle in Koehne Park. She stated that she saw the old white truck with some kind of writing on the side parked there when they arrived. She stated that there was a WM approximately 50yoa with a pair of binoculars out walking around the truck.

Ms. TURNER then told me that she observed the orange Pinto pulling, that two girls and one boy got out of the orange Pinto and they walked down on the Point which is a ledge out into the water, and sat down in a circle talking to each other for approximately 20 to 30 minutes. She further told me that as far as she could tell, no one else walked down to where they were and that no one had talked to them that she could tell, while they were sitting on the Point and it was just those three together.

Ms. TURNER stated that it was starting to get dark and she observed the three of them get up and walk up to the hill towards the orange Pinto. She did not see whether they talked to anyone at the top of the hill by the Pinto or if they got into a car with anyone. She further stated that they did not notice anyone stopping and pulling in between the Pinto and the old white truck as had been indicated by the driver of the old white truck, Mr. RAMSEY. She stated that they had left somewhere between 9:00P and 9:15P, but she was not sure; this being MARTHA DENISE TURNER and the subjects with her. She did not see whether the two girls and boy who had gotten out of the Pinto had left at all or not. She did not believe that the orange Pinto left from the time it pulled in until the time they left, but she is not sure of that either.

She stated that she had not paid much attention to the old white man with the binoculars,

simply that he had on dirty clothes and a cap and that she did not observe him going up on top of the hill and sitting at the picnic table as he had indicated. Ms. TURNER stated that BARD may could shed some more light on this, as he had paid a little more attention to subject than anyone else in the group as did PINKIE. Officer SALINAS has talked to this subject in reference to what she saw at the location.

Ms. TURNER stated that there was a sort of a pastel green car with a man and woman in the car. She stated that it was a large car and that the folks inside the car never got outside of the car during the time that they were there. She said that prior to their leaving, this car pulled away and left the Circle area by Koehne Park.

Ms. TURNER then said that a brownish colored old ragged station wagon with a man and some little kids in the station wagon pulled in and by this time it was starting to get rather dark and they began to get ready to leave. She stated that no one got out of this station wagon that she could remember except for one or two of the small kids who ran around a little bit at the edge of the pavement there in the Circle. This vehicle also left prior to them leaving Koehne Park. She told me that they were in BONNIE's car which is a yellow Ford Torino. I asked her who was driving and she could not remember.

I asked her if the subjects who got out of the Pinto had on any type of unusual clothing or if they were carrying purses. She stated that she did not remember, but that they all had a beer in a hand what she thought was Budweiser, but she was not sure about this either. She remembered somebody having a Budweiser in their hand as they were walking out on the Point. She stated that they had no purses on their shoulders or in their hands when they walked out to the Point. The description of clothing that she gave was that she felt that the boy had on blue jeans and also she could remember the sunglasses that he was wearing, but she could not remember the orange shirt that he had been wearing. She stated she thought that one of the girls, the blonde haired girl being Ms. RICE was wearing what looked to be like a tennis outfit, all white. It is this officer's opinion that she was mistaken or possibly mixed up on the two subjects who had walked out on the area earlier who were wearing tennis clothes. Possibly she saw them as well as the people who
