DEEB also told WILLIE TOMPKINS at the time that he told him and PATTY PICK that he hated KENNETH FRANKS, that the two girls that were killed at Speegleville had been in his store on 7-13-82 prior to being killed.

WILLIE TOMPKINS also said the had seen a white female with blonde hair with DEEB in the store and saw DEEB buying her groceries. WILLIE TOMPKINS told us that her name was DANA DIAMOND and that she was from the HOUSTON area. This was told to him by DEEB.

WILLIE TOMPKINS said that he saw DEEB & DANA DIAMOND in the store one night but that they were not together. He saw DANA DIAMOND leave the store and DEEB follow her out. DEEB came back into the store and appeared to WILLIE TOMPKINS to be irate. DEEB told WILLIE TOMPKINS that DANA DIAMOND got into a truck with a black man.
