SGT. SIMONS & I talked with PATRICK TORRES on Saturday, 9-11-82. According to PATRICK TORRES he was the closest friend of KENNETH FRANKS. He said that BOBBY BREM & KEN FRANKS did do things together but that BOBBY BREM was not thought of highly by KENNETH FRANKS.

PATRICK TORRES said that on 7-13-82 he picked KEN FRANKS up at the WACO HIGH SCHOOL at about 3:30P. PATRICK TORRES was driving his sister's TransAm. PATRICK TORRES took KEN FRANKS home at 2804 Savannah Court and he returned home by about 1:P, 7-13-82. About 2:P PATRICK TORRES said that he received a phone call from KENNETH FRANKS but that he was asleep and his sister had answered the phone.

PATRICK TORRES went to work at about 3:P on 7-13-82 at the BRAZOS LANDING. At approx. 7:P he received a call from KENNETH FRANKS while he was at work. KENNETH FRANKS told PATRICK TORRES that he was bored and wanted him to come to his house after he got off work. PATRICK TORRES told KENNETH FRANKS that he was going to go to his home after work due to the fact that he was tired.

PATRICK TORRES said that he did go home and was contacted on 7-14-82 by BOBBY BREM notifying him that KENNETH FRANKS was missing.

PATRICK TORRES would or could not tell us anything or anyone that might want to do harm to KENNETH FRANKS, JILL MONTGOMERY OR RAYLENE RICE.
